A majority affirmative vote is necessary for passage.

Shall a levy renewing an existing levy be imposed by the Cincinnati City School District for the purpose of

**providing for the emergency requirements of the school district** in the sum of forty-eight million dollars (\$48,000,000) and a levy of taxes to be made outside of the ten-mill limitation estimated by the county auditor to average seven and thirty-four hundredths (7.34) mills for each one dollar of valuation, which is seventy-three and four tenths cents (\$0.734) for each one hundred dollars of valuation, for a period of five (5) years, commencing in 2021, first due in calendar year 2022?
